If the policyowner successfully submits an eligible policy change application* (14 types in total) for his/her active life insurance policy, he/she will receive an additional chance in the lucky draw for each type of policy change application, but at most 1 lucky draw chance will be given for the submission of the same type of application. Each eligible policyowner can receive a maximum of 15 chances in the lucky draw during the Campaign Period.
3. Eligible policy change applications for the life insurance policies include contact information change, autopay setup, payment mode change, beneficiary appointment, fund switching, premium allocation change, name change to Simplified Chinese, benefit protection option change, dividend/Cash Payment/Yearly CashBack Payment Option/Guaranteed Cash Coupon change, dividend allocation change, Premium Deposit Account withdrawal, bonus withdrawal, accumulated Yearly Cash Back withdrawal, and policy loan application. The policyowner must successfully submit the application at myPrudential within the Campaign Period.
